**Award Information**

The Community Engagement Educator Award recognizes and honors one outstanding individual in each of the three higher education sectors (state universities, state/community colleges, independent colleges and universities) for significant contributions to the institutionalization of community engagement by inspiring a vision for service on the campus and supporting faculty, students, and/or campus-community partnerships. Novice professionals in this field who can demonstrate progress will also be recognized and given honorable mention. Winners will be notified in August 2010. If funds permit, it is our intention to recognize and feature finalists at a Awards Gala this Fall. All application packets (application form, professional summary, and resume) should be directly submitted via email, to [awards@floridacompact.org](mailto:awards@floridacompact.org) with the email subject line reading *Community Engagement Educator Award*. Two letters of recommendation, along with the two completed recommendation forms, should be directly submitted from the recommender via email, to [awards@floridacompact.org](mailto:awards@floridacompact.org). **All application packets and letters of recommendation must be received by 5:00pm July 30, 2010.** Applicants will receive an email confirming their packet has been received.

***Applicants for this award will be evaluated on their role in furthering the culture of service and civic engagement on their campus(es).*** The guiding principles for this award come from portions of Dr. Andy Furco's *Self-Assessment Rubric for the Institutionalization of Service-Learning in Higher Education*, as it applies to curricular and co-curricular campus efforts. Outstanding applicants will demonstrate their progress and successes in addressing relevant components of Dr. Furco's rubric, most specifically those briefly listed below:

- Furthering the institutionalization of high quality, curricular and/or co-curricular, service-learning activities within the administrative structure of the campus.
- Expanding awareness of engaged campus activities with faculty and administrators across campus programming (see Campus Compact's Indicators of Engagement and/or the Bridging Document).
- Creating and implementing mechanisms to support and sustain student involvement and empowerment as it is related to service/community-based learning activities.
- Fostering community involvement and participation within campus programming and demonstrating the impact of campus-community collaborations.

**Eligibility**

- A person whose job description and/or work has contributed to the overall success of campus-community collaboration and/or service-learning.
- All applicants must be employed at a Florida Campus Compact member institution in good standing and, if funds permit, it is our intention to recognize and feature finalists at a Awards Gala this Fall. Finalists are expected to participate in the Awards Gala.

**Requirements**

1. A completed **application form**.
2. A **professional summary** addressing all professional activities, including all innovative approaches and efforts to institutionalize community service, service-learning, and or/civic engagement, demonstration of being an advocate for community service, service-learning, and/or civic engagement, efforts to bridge the gap between

academic affairs and student affairs; assisting in the formation of campus-community partnerships; supporting faculty and students involved in service; and/or commitment to student voice and student development.

*\*\*Professional Summary should be a maximum of 3 pages, Times font, 12 point, and double-spaced.*

*Photographs/PR material may also be included.*

3. **At least two letters of recommendation (with completed recommendation forms)**, from a campus administrator, faculty member, student, or community representative who is familiar with your work. At least one letter should be from a community partner.

4. **Curriculum Vitae or Resume.**
